Announcement

The Second Council meeting of the Asia and Oceania Federation of Obstetrics and Gynaecology was held at Phuket on 28 October 1994. The Council meeting decided that the Federation's official journal *Asia-Oceania Journal of Obstetrics and Gynaecology* changes its name to *The Journal of Obstetrics and Gynaecology* and is published bi-monthly rather than quarterly from this issue.

The Journal's Abstract format has been changed. We would appreciate it if you would rewrite your abstract in line with the following instructions.

A structured abstract is required for certain types of articles, and a standard abstract format is required for other types of articles; author(s) should select and prepare the appropriate abstract to be used in the submitted manuscript.

Structured abstract: A structured abstract, limited to 150 words, is to be used for regular articles; excluded are Clinical Opinion, Current Development, Case Reports, and Reviews. The structured abstract is to contain the following major headings: Objective(s): Methods (Study Design); Results; and Conclusion(s). The Objective(s) reflects the purpose of the study, that is, the hypothesis that is being tested. The Methods (Study Design) should include the setting for the study, the subjects (number and type), the treatment or intervention, and the type of statistical analysis. The Results include the outcome of the study and statistical significance if appropriete. The Conclusion(s) states the significance of the results.

Standard abstract: The standard abstract format is required for Clinical Opinion, Current Development, Case Reports, and Reviews. Standard abstracts are to be limited to 50 words.

INSTRUCTIONS TO CONTRIBUTORS

SUBMISSION OF CONTRIBUTIONS

- 1. All articles accepted for publication in this Journal must be exclusive contributions. Therefore, all manuscripts must be accompanied by the following written statement: "The undersigned author warrants that the article is original, is not under consideration by another journal, and has not been previously published. I sign for and accept responsibility for releasing this material on behalf of any and all co-authors."
- 2. Contributions from member countries should be submitted through their representatives on the editorial board. Contributions from non-member countries should be submitted directly to Prof. Y. Kuwabara, Editor-in-Chief, The Journal of Obstetrics and Gynaecology, Department of Obstetrics & Gynecology, Juntendo University School of Medicine, 2-1-1, Hongo, Bunkyo-ku, Tokyo 113, Japan.
- 3. The editorial board can not be held responsible for views expressed in papers published in the Journal.

MANUSCRIPTS

- 1. Manuscripts must be submitted in English.
- 2. Each manuscript may occupy 8 published pages in the Journal. This means that the approximate length of the manuscript we expect to receive from you is 20 pages on ordinary typewriting paper (10 words×25 lines per page). Please decrease your text pages in proportion to the illustrations you would like to include.
- 3. Manuscripts should be typed on 21.5×28 cm (standard 8.5×11 inch) paper, on one side only, with double spacing and margins of at least 2.5 cm. The original and two goodquality copies are required.
- 4. Each manuscript component should begin on a new page, in this sequence; title page; abstract and key words; text; acknowledgements; references; tables and illustrations; legends for illustrations. In an original article, the text should comprise Introduction, Materials and Methods, Results, and Discussion.
- 5. The title page should contain (1) the title of the article; (2) first name, middle initial and last name of each author; (3) name of department(s) and institution(s); (4) address of the principal author; (5) the source(s) of support in the form of grants; and (6) a short running title of no more than 40 characters (count letters and spaces). For emergency use, please give your FAX number; if not available, telephone number.
- 6. The second page should carry an abstract.

Standard abstract: The standard abstract format is required for Clinical Opinion Current Development, Case Report and Reviews. Standard abstracts are to be limited to 50 words.

- 7. Only recognized abbreviations should be used.
- 8. The surname of the principal author should appear in the top left-hand corner of each page.

TABLES AND ILLUSTRATIONS

- 1. Each table and its title should be on a separate sheet of paper, and its position indicated in the text. Tables should be numbered in Arabic numerals. Captions should be brief, yet indicate clearly the purpose or content of each table.
- 2. All illustrations should be submitted unmounted, in black ink drawings of professional quality or glossy photographs. The author's name and the figure number should be written lightly in pencil on the back of each illustration. The word "top" should be written in the appropriate place on the back of the illustration. A legend should be supplied for each illustration, with all legends typed on separate sheets of paper.
- 3. Lines in charts should be in black; graph paper, when used, should have gray or faint blue ruling.
- 4. X-ray prints, not films, should be submitted. Where prints are poor a tracing of the outline should be submitted with the X-ray prints.
- 5. Magnifications of microscopical illustrations should be given in the legends (e.g. ×250).
- 6. Illustrations should be a maximum size of 12×10 cm (5×4 inch). Any words, numbers, and symbols which are part of an illustration should be large and clear enough to remain legible when the figure is reduced to column width.
- 7. Photographs should not be larger than cabinet size (13×18 cm).
- 8. Color illustrations are allowable only in special circumstances, and the author will be expected to meet the cost of reproduction.

PEFERENCES

Reference citations should be numbered (in arabic numerals) consecutively in the order in which they are first mentioned in the text. The titles of journals should be abbreviated according to the style used in *Index Medicus*. Examples of correct forms of references follow.
